This role manages approximately \$10M in grants for the Department of Justice, the Federal Agency of Health and Human Services and the State of Vermont and grants to approximately 60 different victim service organizations in the state. This is an opportunity for a mission driven individual, who can build upon established relationships, from the front-line victim services providers in Vermont, to the federal agencies that oversee the regulations and provide the funding and training on best practices for assisting individuals whose lives have been impacted by crime.
